

# CAP SANTE HIGH SCHOOL CONTRACT (Page 1 WSLP)

An alternative learning experience means a course that is a delivery method for the program of basic education and is: Provided in whole or in part independently from a regular classroom setting or schedule, but the learning plan may include some components of direct instruction; is supervised, monitored, assessed, evaluated, and documented by a certificated teacher; and provides guidance through a written student learning plan. This alternative learning experience ensures that students enrolled have available to them educational opportunities designed to meet their individual needs.

1. **As an onsite learner**, I understand Cap Sante's onsite learning component consists of a resource room model where I have ongoing contact with a circulating certificated teacher who provides as-needed direct instruction, review of assignments, testing, evaluation of my academic progress, redirection or motivation to help keep me on task to the learning requirements and/or activities specifically outlined in my Student Learning Plan(s). As part of my Written Student Learning Plan, I will be in attendance onsite specific days and/or times as scheduled by the Certificated Teacher according to my individual Student Learning Goals.

2. **As an offsite learner**, I understand that I am required to make weekly "direct personal contact" with my instructor(s).

"Direct personal contact" means a one-to-one meeting between a certificated teacher and the student, or, where appropriate, between the certificated teacher, the student and the student's parent. Direct personal contact can be accomplished in person or through the use of telephone, e-mail, instant messaging, interactive video communication, or other means of digital communication. Direct personal contact:

- (i) Must be for the purposes of instruction, review of assignments, testing, evaluation of student progress, or other learning activities or requirements identified in the written student learning plan;
- (ii) Must be related to an alternative learning experience course or course work identified in the written student learning plan; and
- (iii) Must at minimum include a two-way exchange of information between a certificated teacher and the student. (WAC 392-121-182)

3. Options include **onsite** and **offsite**, self-paced, learning utilizing hardcopy and online curriculum. Attendance is individualized and determined by course load and the estimated time needed to make adequate academic monthly progress. Students must make adequate academic monthly progress in order to remain enrolled at Cap Sante High School. Students are required to satisfy all district and state graduation requirements.

❖ **Adequate Monthly Progress:**

- Means a determination is made that a student's progress toward achieving the specific learning goals and performance objectives specified in the written student learning plan is satisfactory. (WAC 392-121-182)

**If a progress improvement plan is required**, the following options may be utilized to aid students to make continued progress towards their academic goals:

- Increasing the frequency or duration of direct personal weekly contact for the purposes of enhancing the ability of the certificated teacher to improve student learning; this may include increasing student time onsite.
- Modifying the manner in which direct personal weekly contact is accomplished;
- Modifying the student's learning goals or performance objectives;
- Modifying the number of or scope of courses or the content included in the learning plan.

❖ **If lack of progress continues to occur**, the improvement plan could include being transferred to another educational option better suited to meet the student's needs.
